Asian Boxing is a non-profit, continental sports federation dedicated to prioritizing the welfare of boxers and ensuring that boxing remains central to the Olympic movement within Asia. It is responsible for governing all forms of boxing across the continent, with its establishment under Switzerland Law, and its central administration office based in Bangkok, Thailand. The President may also establish additional decentralized offices as needed.

Asian Boxing was founded by 18 National Federations across Asia in response to the ongoing issues within the international governing body of Olympic-style boxing.

#### **ESTABLISHMENT**

Asian Boxing is a civil association founded for an unlimited period of time having its own legal identity as a non-profit organisation in accordance with Article 60 of the Swiss Civil Code.


#### REGISTERED
