3.1. Participating Boxers

- U15 Boys & Girls boxers between the age of 13 and 14 according to their year of birth (born between 2012 - 2013) will be eligible to compete in the following categories:
30-33kg, 35kg, 37kg, 40kg, 43kg, 46kg , 49kg, 52kg, 55kg, 58kg, 61kg, 64kg, 67kg, 70kg, +70kg.
- U17 Boys & Girls boxers between the age of 15 and 16 according to their year of birth (born between 2010 - 2011) will be eligible to compete in the following categories:
44-46Kg, 48Kg, 50Kg, 52Kg, 54Kg, 57Kg, 60Kg, 63Kg, 66Kg, 70Kg, 75Kg, 80Kg , +80Kg.
- Reserve Boxers: If your National Federation is hesitating between 2 boxers, or simply wants to prevent any injury, please register the "Reserve boxer" on the registration form. This function will allow you to register more than one boxer in the same category, and you will have the possibility to choose last minute which boxer will participate even after registration ended (only one boxer will be allowed to compete in each category)

3.2 Team Officials

Each Team Delegation can have the following number of Team Officials:

Team Manager	: 01
Team Physician	: 01
Physiotherapist	: 01
Extra Person	: Open

Number of coaches according to below table:

1-3 Boxers	: Up to 4 Coaches
4-7 Boxers	: Up to 5 Coaches
8-10 Boxers	: Up to 6 Coaches
11 or more Boxers	: Up to 12 Coaches

3.3 Coaches and R&J s

- Each Boxer will be entitled to be accompanied to the ring by up to three (3) Coaches.- Only two (2) Coaches may mount the apron of the ring and only one (1) may enter the ring.
- All boxers must be accompanied by at least one World Boxing certified coach at ringside during the bouts.
 - All Coaches allowed to work in the Field of Play (FOP) must be World Boxing certified .
 - If any team does not have a certified coach, please raise this at the Technical Meeting so arrangements can be made with another team.
 - Any coach of National Level, who has not World Boxing certified, will not be allowed to enter the FOP.
 - All R&J's will be nominated by their respective National Federations and the final approval will be granted by Asian Boxing.
 - The R&J's nominated by NF should be World Boxing certified - The respective National Federations will pay the airfare for the approved RJ's and the LOC will provide transportation to venue, accommodation and per diem.

4.1. Process

The visa requirements for entry into Uzbekistan for Asian countries. Kindly note that the e-visa process typically requires up to five (5) working days, while visas for countries requiring consular processing are issued within approximately seven to Ten working days. We would appreciate your support in informing participating federations and facilitating visa support letters where necessary.

The process for obtaining visa for Uzbekistan will be as follows:

- Team delegations who needs Visas must immediately request it to Uzbekistan Boxing Federation.
- All visas will issue through the Uzbekistan Boxing Federation, And every team will receive a visa upon arrivals. Or Visa support letter for the embassies.

8. COMPETITION SYSTEM

- The Championships will be conducted according to current World Boxing and Competition Rules.
- The Official Draw will be conducted by Swiss Timing system and Asian Boxing reserves the right to make changes in accordance with any situation.
- The Scoring System will be based on a "Ten Point Must System".
- There will be five (5) Judges for each bout in accordance with electronic draw by Scoring System.

10. SPECIAL REQUIREMENTS

10.1 All boxers must bring the following items to the sports entries check:

- Boxer's Passports
- Boxer's International Record Books
- Boxer's World Boxing Medical Certificate (Issued within the last 3 months)
- Video consent form
- Image rights consent form
- Uniform and robe (if applicable)
- Non pregnancy for girls

10.2 Each team Delegation must also bring the following:

- National Flag 1X1.5 m
- National Anthem on USB Drive/ CD in .mp3 format.

10.3 Boxer's Uniform:

- The vest and shorts/skirt can be in the Boxer's respective national colours or in red or blue colour according to the Boxer's respective corner allocation
- Teams should review and ensure full compliance with the World Boxing Competition Rules, point 13.5, prior to arrival at the championship, to confirm that all uniforms meet the required standards.

10.4 official boxing equipment

- All official boxing equipment used at Asian Boxing Championships will be provided exclusively by Asian Boxing through its official and exclusive equipment partner, Greenhill.
- No alternative equipment may be used unless expressly authorised in writing by Asian Boxing.

11. MEDALS

Medals will be awarded by Asian Boxing and provided by the Uzbekistan Boxing Federation.

12. ACCREDITATION

For Team Delegations

All delegation members who have registered for the Asian Boxing U15 & U17 Boxing Championships, Tashkent 2026, through the official Asian Boxing Registration Form by April 01, 2026, will receive their accreditation upon payment of the accommodation fees to the Local Organizing Committee (LOC).

13. INSURANCE

All accredited participants must have their own travel, medical, repatriation, and liability insurance covering the entire event and travel period.

14. MEDICAL CARE

The LOC will provide first aid during the entire event period to any participant who suffers from a sports injury contracted during the event.

15. IMAGE RIGHTS & VIDEO RECORDING

- Asian Boxing retains full and exclusive image, broadcast, and recording rights for all Asian Boxing Championships.
- Asian Boxing and its appointed partners are authorised to film and photograph the event for official, broadcast, promotional, and archival purposes.
- Photography by accredited media is permitted only in approved areas and in accordance with Asian Boxing Media protocols.
- Video recording of bouts or competition activity is not permitted unless expressly authorised in writing by Asian Boxing Media.
- All filming locations within the venue are restricted and controlled by Asian Boxing Media. Only media accredited through Asian Boxing will be permitted to capture images or access media areas. Media accreditation requests must be submitted directly to Asian Boxing.
